

MEMBERSHIP & GUEST FEES INFORMATION

One does not need to be a member of the Center to make use of our facilities or partake in our fitness classes, nor does one need to be resident of the City for occasional visits.

Membership is recommended for those who will be making frequent use (two or more times a week) of the Center. Membership rates are determined by first residency; defined as living or working in the City of Cohoes, and then by age bracket or “tier”

TIERS OF MEMBERSHIP-DEFINITIONS:

- Family:** “Two adults and up to four children under the age of 18”
Single Adult: One adult membership for ages 19-59.
Senior Citizen: One senior membership for ages 60+
Young Adult: Youths 13-18 years of age.
Youth: Children 7-12 (children under 7 are free, but must be accompanied by an adult)

Membership plans are offered for three, six, and twelve months. Prospective members can also make use of our “Easy Payment Plan” for the yearly plans. Please note that the Center currently does not offer monthly plans or monthly payment options. With the exception of the Easy Payment Plan, payment for membership must be rendered in full upon enrollment.

Existing members of the yearly plan have a 30 day grace period to renew their membership at a discounted rate.
